Access to justice & effective remedies for children whose identity rights have been contravened

The Identity Rights Working Group¹, co-chaired by Child Identity Protection (CHIP) and the Institute on Statelessness and Inclusion (ISI) is hosting a webinar series dedicated to access to justice and effective remedies for children whose identity rights have been contravened.

It is a follow-up of an expert meeting that brought together several members of the Committee on the Rights of the Child (CRC Committee), representatives of UN agencies, non-governmental organizations, academics and persons with lived experience.²

The central focus of the series will be to explore the various challenges that arise when Articles 7 and 8 of the Convention on the Rights of the Child (CRC) are violated and the consequences for access to justice. The child's right to identity is an independent right and is also the gateway for accessing other rights, such as education and healthcare. When children

lack some or all elements of their identity, they are rendered legally invisible making them susceptible to severe forms of human rights violations and unable to enjoy basic rights such as education and healthcare. Relatedly, their ability to access justice and remedies is severely undermined, because their 'lack of (legal) existence' makes it impossible from them to establish legal personality, a basic concept that underscores access to justice. Four webinars each lasting 90 minutes will be held, mirroring the structure of the expert meeting with same themes and experts, where possible.

Right to family relations and access to justice and effective remedies.

The final webinar will focus on the right to family relations against the backdrop of less regulated and emerging developments such as alternative care, adoption, assisted reproductive technologies and surrogacy. To prevent the need for access to justice for violations of right to identity in family relations, discussions will focus on the need to prohibit anonymous practices leading to gaps in information about origins – biological, gestational, legal and social. This requires systematic recording of all relevant elements of the child's identity.
